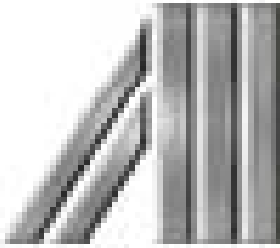
#### Personal Protective Equipment

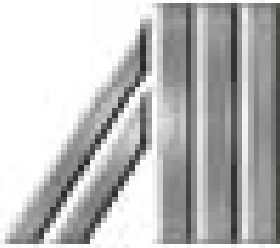
